The applications are invited for the post of the Registrar of the Institute. Interested persons may apply in the prescribed online application form available at the Institute website http://www.svnit.ac.in.Candidates are advised to fill up the form online and download the online submitted application form. The downloaded application form with duly self-attested supporting documents, such as relevant testimonials, certificates, enclosures must be sent by speed/ registered post or by hand, to the Registrar, SardarVallabhbhai National Institute of Technology, Ichchhanath, Dumas Road, Surat within the prescribed due date ,failing which, their candidature will not be considered.

General Instructions:

- 1. Canvassing in any form will disqualify the candidature of the applicant.
- 2. More than six months of experience in regular position in any organization will only be considered as the total experience. Experience rendered on part-time, daily wages or as visiting faculty will not be counted as experience.
- 3. The Institute reserves the right to set higher criteria than the Essential Qualifications for short listing the candidates.
- 4. Travelling allowances will be paid to the candidates called for theInterview as per following norm:
