Qualification - Candidates who have successfully passed their Diploma in the Branch/Discipline mentioned above in the years 2017/2018/2019 from recognized institution by the Government shall be eligible. Candidates should have passed qualification examination after 01.01.2017.

MAXIMUM - 27 Years (General) 30 Years (OBC) 32 Years (SC/ST)

10 years relaxation will be given for 'Person with Disability' candidates. "Person with disability" means a person suffering from not less than forty per cent of any disability (Low Vision/ Loco motor disability / Hearing Impairment) as certified by a medical authority as per 'The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995. Persons with not less than 40% of the relevant disability shall alone be eligible.

Employee Wards of BHEL (Wards of Serving & Deceased employees) – An additional 05 years relaxation in age shall be given to wards of BHEL Employees.

- Candidates may note that, if selected as Graduate Apprentices (Engineering) / Technician Apprentice, completion of training will be subject to registration by Board of Apprenticeship Training, Southern Region, Chennai. If due to any reason BOAT refuses registration, the training will be terminated and he/she will not be issued with the relevant certificate.
