- 9. OBC candidates are required to submit their caste certificate (issued before the date of application) issued by the Govt. of NCT of Delhi and shall have declared non creamy layer status on the day of the interview on prescribed format.
- 10. In case of non-availability of SC/ST/OBC candidates, the post shall be filled from General category.
- 11. Selected candidates shall be allowed a maximum of 07 days time for accepting the offer of appointment and thereafter 07 days for joining from the date of acceptance, failing which the offer shall stand cancelled.
