 - (ii) With 3 years regular service in posts Level-6 of pay matrix (R\$.35400 112400) or equivalent, OR
 - (iii) With 8 years regular service in posts Level-5 of pay matrix (Rs.29200 92300) or equivalent AND

b) **Possessing educational qualification**

- Master's Degree in Zoology/ Marine Biology or Bachelor's Degree in Fisheries Science from a recognized University or equivalent.
- (ii) 2 years experience in Fisheries Development.
- (iii) Desirable

Master's Degree in Fisheries Science from a recognized University or equivalent or Post Graduate Diploma in Fisheries Science issued by CIFE, Mumbai.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appoint on deputation. Similarly, deputationist shall not be eligible for consideration for appoint by promotion (Period of deputation including period of deputation in an other ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not be exceed three years. The maximum age limit for appointment by transfer on deputation (including short-term contract) shall be, not exceeding 56 years, as on the closing date of receipt of applications).
