- (II) The Departmental Statistical Investigator in pay band-2, Rs. 9300-34800/- plus grade pay of Rs.4200/- (pre-revised) or Pay Matrix Level-7 (revised as per 7th CPC) with eight years regular service in the grade shall also be considered along with deputationists and in case he or she is selected for appointment to the post, the same shall be deemed to have been filled by promotion.
