Currently Metro Projects have been sanctioned by Gol for cities of Bhopal and Indore. The projects in these two cities has just started and likely to be completed by 2023.

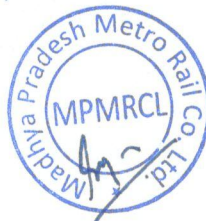
2. **JOB DESCRIPTION AND RESPONSIBILITIES**

The pay scale of the post is `200000-370000 (IDA) and other allowances/perks/privileges as applicable to the post of Managing Director as per the company's rules.

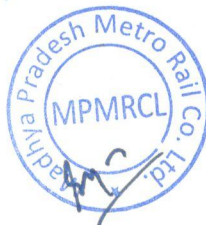
4. Duration of appointment:-
