### **RADIO MECHANIC**

**Deputation (including short-term contract): failing which by direct recruitment.**

Officers under the Central or State Governments or Union territories or Public Sector Undertakings or recognized research Institutions or Semi-Government or statutory or autonomous organizations:-

- holding analogous posts on regular basis in the parent cadre/Department; or
- with 5 years regular service as in the **Pay Level-4** (Rs. 25500-81100) **and** possess Educational and other qualifications required for direct recruitment in **Column 7 of Recruitment Rules.**

**Note 1:** The Departmental officers in the feeder category who are in the direct line of promotion shall not be eligible or consideration for appointment on deputation, similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

**Note 2:** The Period of deputation (including short-term contract) including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central shall ordinarily not exceed 3 years.

**Note 3:** The Maximum age limit for appointment by deputation (including short-term contract) shall be 'Not exceeding 56 years' as on the closing dated of receipt of applications.

**Note 4:** For the purpose of appointment on deputation/absorption basis, the service rendered on a regular basis by an Officer prior to 1st, January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay/Pay scale and where this benefit will extend only for the post or posts for which that Grade Pay or Pay scale is the Normal replacement grade without any up gradation
