- 2 It is clarified that no contractual staff under NHM should be recruited without proper advertisement and secreening test.
- The secreening test/proficiency test is a test to check IQ, General Knowledge and information of the candidate about concerned subject.
- For every post, advertised, atleast 4-5 times the number of eligible candidates should be shortlisted through secreening/proficiency test. If the total number of applicants are less, than 2-3 times the number of eligible candidates should be shortlisted through secreening/proficiency test. Those candidates who are unable to get 40% in screening /proficiency test should not be shortlisted for further interview.
