I. COMPANY PROFILE

Bharat Petro Resource Limited (BPRL) was incorporated in October, 2006 as a wholly owned subsidiary of Bharat Petroleum Corporation Limited (BPCL), for carrying out the upstream oil & gas business of BPCL. The primary objective of the company will be to develop a focused approach towards building the exploration business and to implement the investment plans of BPCL at a quick pace. Assimilation of latest upstream technology, expeditious placement of competent human resources and developing necessary infrastructure shall also assume equal importance. BPRL is a schedule 'B' CPSE with the administrative jurisdication of Ministry of Petroleum and Natural Gas. The company employed 47 regular employees (Executives- 47, Non-executives-0) as on 31.03.2020.

Its Registered and Corporate Offices are in Mumbai, Maharashtra.

The authorized and paid up share capital of the Company were Rs.15000 crore and Rs. 5000 crore respectively as on 31.03.2020.

The Government has approved strategic disinvestment of Govt. of India shareholding of 53.29% in BPCL alongwith transfer of management control to a strategic buyer.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Finance) is a member of the Board of Directors and reports to Managing Director. He/She is overall in charge of the finance and accounts of the organization and is responsible for



evolving and formulating policies related to finance and accounts as well as implementation thereof.
