NOTIFICATION

The Hon'ble High Court has been pleased to notify the status of vacancies in **Grade-III of Tripura Judicial Service** as on 31.12.2020 in terms of order dated 04.01.2007 of the Hon'ble Supreme Court of India passed in Civil Appeal No. 1867 of 2006 with Nos. 1868-72 of 2006 (*Malik Mazhar Sultan(3) and another Vrs. Uttar Pradesh Public Service Commission and others*) which is as follows:

For appointment to the posts of Civil Judge (Junior Division) by direct recruitment

For filling up 08 vacancies by the High Court [50% of the total vacant posts] after completion of process of recruitment, name of 02 successful candidates have been recommended to the State Government for appointment in the Grade. Out of 02 candidates, 01 candidate has joined in the Service on 01.12.2020 vide Notification No. F.2(1)-LAW/ESTT.2/2020/9506-41, dated 25.11.2020 of the Law Department, Government of Tripura and another candidate is yet to be joined.

For filling up 07 vacancies [50% of the total vacant posts], the Tripura Public Service Commission conducted the recruitment process and the same is yet to be completed.

As on date, for filling up remaining 06 [14-1-7] vacancies to be filled up by the High Court as per Tripura Judicial Service Rules, 2003 (as amended up to date) Advertisement inviting applications from eligible candidates will be issued on 1st February, 2021 and Preliminary Written examination may be conducted on 16th May, 2021.

b. Future Vacancies that may arise within one year due to retirement	Retirement- Nil
c. Future vacancies that may arise due to promotion, death or otherwise, say ten percent of the number of posts.	Promotion- 05 [ten per cent of total sanctioned posts i.e. ten per cent of 49]
