I. COMPANY PROFILE

National Seeds Corporation Limited (NSC) was incorporated under the Indian Companies Act, 1956 with the objective to promote and develop seed industry in the country and to contribute to the prosperity of farmers through supply of quality seeds and other agro inputs/services as well as to enhance agricultural productivity. NSC is a Schedule 'B' Mini Ratna CPSE in Agro based industries sector with the administrative jurisdiction of Department of Agriculture & Cooperation and Farmer Welfare, Ministry of Agriculture and Farmer Welfare.
