The Delhi Metro Rail Corporation (DMRC) Ltd., a Joint Venture company with equity participation from Govt. of India and Govt. of National Capital Territory of Delhi has been entrusted with the responsibility of implementation of the rail-based Mass Rapid Transit System for Delhi. The Delhi Metro Rail Corporation, Lifeline of Delhi, prides itself on its ability to nurture its employees through its unique work culture. Today, DMRC empowered by about 14,500 employees with MRTS activities spread over Delhi NCR, Jaipur, Kochi, Mumbai, Patna etc., carry about 3 million passengers per day in Delhi & NCR. In addition to the above, DMRC is involved in providing consultancy services to number of cities within India and abroad.

To meet with the immediate requirement of experienced personnel for DMRC and its allied projects, applications are invited from retired / experienced, dynamic and motivated persons having experience of working in Indian Railway / Railway PSUs for the following **Non-Executive posts in DMRC to be filled on Post Retirement Contractual Engagement / Deputation basis for O&M department of DMRC: -**

Candidates must be working / retired in the functional grade, on regular basis and MACP will not be considered.

2. Experience criteria:

Candidates should possess at least 10 years of experience in Railway workshop in the field of Axle grinding, wheel boring, Disking / un-disking of wheel set of Rolling stock and allied activities. Expertise in handling of CNC machine is essential requirement. Credentials in support of aforesaid experience to be enclosed along with application.

3. Selection process:

The selection methodology will comprise of Personal Interview. The selection process would judge different facets of knowledge, skills, experience, expertise, aptitude and physical ability. The candidates will be shortlisted for interview, based on their eligibility / relevant work experience, in the ratio of 1:5, subject to availability of candidates.

4. Pay and Emoluments:

i) For candidate selected on Deputation basis –

The selected candidate shall continue to draw parent department pay plus deputation allowance, as applicable, under the Govt. of India rules.

ii) For candidate selected on PRCE basis –

The selected candidate shall be eligible for a consolidated pay of Rs. 55,800/- pm for the post of Senior Section Engineer / Rolling Stock.

The emoluments are in terms of extant rules of DMRC. The substantive status of the candidate shall be considered. The consolidated pay for candidates working / retired at higher Grade will be restricted to emoluments as mentioned above.

5. Schedule of selection:

- i. Last date of receipt of duly filled in application (along with relevant documents) through Speed post is **27/04/2021**. Incomplete applications or applications received after the due date will be summarily rejected. DMRC shall not be responsible for loss / delay in post.
- ii. **The list of shortlisted candidates shall be uploaded on DMRC website in the Second week of May 2021 (tentatively) and interview will be held in the third week of May, 2021 at Metro Bhawan, Barakhamba Road, New Delhi or through online mode (tentatively) (Complete details will be displayed on DMRC website).**
- iii. No separate communication, by post, will be sent to candidates individually. Candidates are required to go through the instructions / schedule for interview displayed on DMRC website and appear for the interview, accordingly along with original copies of testimonials.
- iv. **The final result will be declared by fourth week of May, 2021. (Tentatively).**

Eligible and willing candidates for the aforesaid post may apply as per the application format at Annexure-I. The candidate must enclose all relevant documents in support of qualification, work experience, pay & pay scale (last drawn, in case of superannuated candidates).

The candidates who are superannuated from Indian Railways or Railway Public Sector Undertaking (PSUs) should send their application along with the copies of APARs for the last five years. The candidates presently employed in Indian Railways or Railway Public Sector Undertaking (PSUs) should send their application through proper channel along with the copies of APARs for the last five years, Vigilance and D&AR clearance, so as to reach the below mentioned address / email by the stipulated date. The applications received after the due date will be summarily rejected.
